## Brooklyn Village Board Meeting Minutes November 15, 2016

The November 15, 2016 Village Board meeting of the Village of Brooklyn was called to order at 6:30 p.m. at the Village Hall by President Pat Hawkey. Trustees present were Sue McCallum, Kyle Smith, Heather Kirkpatrick and Russell Cazier. Trustee Todd Klahn arrived at 7:13 p.m. Trustee Bruce Crubaugh was absent. Others present were Clerk-Treasurer Linda Kuhlman, Public Works Director Mark Langer and Chief Barger. Dan Dean arrived later. All present stood for the Pledge of Allegiance. **A PUBLIC HEARING FOR THE 2017 BUDGETS** was conducted: General Fund, Special Revenue Fund, Cemetery Fund, Debt Service Fund, Capital Project Fund, Water Utility, Sewer Utility, TID #1 Fund, and TID #2 Fund. There were no public comments and the hearing closed at 6:32 p.m.

There were **no public comments**. Hawkey made a **motion to approve the minutes of 10-10-16 and 10-24-16**. McCallum seconded. Cazier abstained, motion carried.

**President's report** – The board was given a copy of a **Thank You from Public Works to Seneca Foods** for the donation of food for the Thanksgiving Back Food Drive sponsored by Pellitteri. All of the donations received from Village of Brooklyn will go to the Oregon/Brooklyn Food Pantry. Hawkey reminded residents that **off-street parking for winter started last night at midnight**. This information will also be in the newsletter and on the LED sign. Hawkey suggested that the Village Board raise the rates of pollworkers in the future. She would like to **thank all the pollworkers** – Meagan Hamlette, Nadine Walsten, Zach Leavy, Sandy Glasier, Deb Voegtline, Gail Bauer, Anna Johnson and Marge Van Calligan. It was well run and went off without a hitch. Thanks also to the Clerk and Deputy Clerk for their hard work. Village had 87 absentee voters. Election day was very busy but well run because of all the workers. Thanks also to Gail, Deb and Anna, who are new workers and volunteered and did a good job. McCallum wanted to say thank you also for posting the results on the website and other normal posting places.

**Clerk's Report** – Monthly financial reports were given to board members. Clerk Kuhlman had **nominated Brooklyn for a DNR Recycling Excellence Award but it was denied**. However, the DNR did thank the Village for their continued recycling program. Kevin Ripp from Aquafix had contacted the clerk regarding a **group at the UW that is working on algae testing for the phosphorus issue**. He would like to come before the board with the group. Clerk Kuhlman suggested he get the board more information first and they will be put on the agenda after the first of the year. **US Cellular needs to do upgrades to the tower and will be applying for a zoning and building permit**. They do need to have a form signed by us as holders of the lease on the property to give them permission to do the work. **Nomination process starts December 1, 2016 for Village President and 3 Trustee positions**. Filing deadline is January 5, 2017. Nomination packets are available in the clerk's office. December 28 is the last day to file Notification of Non-Candidacy.

**Public Works Report** – Siren is still not working. They will follow up and get back to the board. It does **work for emergencies**. **Utility report** – sewer mains have been cleaned and lift station cleaned again. Board members need to finish the Emergency Management binders. **Public Works Report** – Lincoln Street has been pumped for the third time this year, so that account will be over budget this year. Leaf pickup is going well; there were a few issues with some tires and a hose. Hawkey thanked Public Works for setting up for the election. The winterizing of the wells is almost done. They will be starting to put up Christmas decorations this week.

**Safety Report** – **nothing new on the stop sign at Rutland and Highway 92**. Hawkey will continue to have this on the board agenda so that the residents are notified. Chief's report was handed out to residents. **DaneCom switchover** is going well. Put a **new battery in the squad** after three years. **Working through LERMS problems** from a recent upgrade. **Officer Burns hasn't been working recently because he and his wife had a baby 4-5 weeks ago**. Board would like to pass on congratulations to him and his wife. **Training group** met last week because Cottage Grove left the group, so they're doing reorganization and getting training set up. **Still working with Dane County to get our ordinances** into the state system. Kirkpatrick asked questions on DaneCom and why is it more difficult for us to communicate with Green County now; what do you have to do differently. Chief stated DaneCom went live on 9<sup>th</sup> of November. Working well but problem is that because outside of Dane is non-trunked radio system, Dane County has created themselves to be an island. Now, he can't have Green County on same DaneCom banks that they work off of day to day. So now they have to stop car, switch over to another zone and bring them up to talk to them, can't scan either way. They are working on a solution to solve this problem. Don't know how Fire and EMS are working because outside agencies don't have DaneCom and can't communicate on DaneCom. Hawkey said Fire/EMS has appropriated money to upgrade radios for DaneCom, but it will still be difficult. Chief stated also can't do a third channel, so if something is happening in Rock, will have to stop and switch channels.

Hawkey passed around to all board members a complaint she received from a resident. **No recreation committee update. Fire/EMS cancelled their meeting for November.** Village board members were at the Town of Brooklyn meeting last night when Wayne Ace asked the Town of Brooklyn to come to a meeting of all municipalities. Discussion was held regarding the meeting. Kirkpatrick suggested meeting with Village attorney before the joint meeting of municipalities.

**Hawkey made a motion to accept bills as presented.** Kirkpatrick seconded. Motion carried. **McCallum made a motion to approve Resolution 2016-09 Green County Matching Road Funds.** Kirkpatrick seconded. Motion carried. **Smith made a motion to approve the Operator Licenses for Cody Bobzien and Sharon Wienke.** Hawkey seconded. Motion carried.

**Budget discussion** – Hawkey stated after the October 24 budget meeting, the mill rate was calculated to be \$8.44/1000. Last year the board had a discussion about keeping the mill rate close to the previous year. Last year's mill rate was \$9.16. The proposal is to add \$50,000 back into the budget, which would bring the mill rate to \$9.02, which keeps it in the range the board discussed last year. Hawkey suggested using \$10,000 for the Clearas testing that was discussed at the last board meeting, \$600 for Fly Dane, which is GIS mapping of the Village, \$1,400 to do surveys of Village Property at 103 Hotel Street, the alleyway behind the bars on Hotel Street and the Community Building, and then put the remaining \$38,000 into engineering to help fund for the DNR phosphorous removal requirements, design, etc.

Board members discussed various budget items and where to apply the funds. The board made the following budget decisions. **The Police Department is authorized to purchase two computers out of existing 2016 funds in the squad car replacement fund. The Police Department is also authorized to continue to evaluate and assess the purchase and installation of the Spillman software in 2017 using fund balance proceeds.** The purchase will be reviewed again in 2017 when more details are available.

**\$8,000 will be put into General Fund Engineering for the Clearas Testing** to be done in February. **\$600 is designated for Fly Dane. \$1,400 is designated for survey of property owned by the Village** -- 103 Hotel Street, alley behind the bars on Hotel Street and the Community Building. In addition to the survey for the Community Building, the Village will contact the property owners next to the building to discuss fencing that will hopefully discourage people from going onto private property while holding events at the Community Building. **The remaining \$40,000 will be put into the General Fund Engineering account to be used for fees associated with the DNR phosphorus removal program and also to research solutions for the water drainage issue on Bowman Street.** In researching this drainage issue, the Village will contact homeowners on Bowman Street to discuss the option of a water garden or drainage area, so that a solution can be determined and budgeted for in 2018.

Clerk Kuhlman explained the 2017 budget was under the formula of 1.1% for **Expenditure Restraint** to be eligible for 2018 funds. The **levy will be \$773,624.89** less exempt computer aid, which is \$10,924 less than last year. The **mill rate will be \$9.02**, which is 14 cents less than last year. **Hawkey made a motion to approve 2017 fund budgets and Resolution 2016-10 for 2016 Tax Levy Payable 2017.** Klahn seconded. Motion carried. **Hawkey made a motion to approve the Levy Limit Worksheet and mill rate worksheet at \$9.02/1000.** Smith seconded. Motion carried. **Hawkey made a motion to approve taking delinquent utilities, special assessments, special charges to the 2016 tax roll payable 2017.** Kirkpatrick seconded. Motion carried. President Hawkey thanked everyone for watching their budgets this last year and hopefully the Business Park will help in the future.

Hawkey made a motion to move chicken ordinance to next month. Klahn seconded. Motion carried. Dan Dean from EMS asked if there were any questions for him on the budget. He'll try to answer any questions. Hawkey stated the dollar amounts are in the Village budget. Hawkey asked to clarify a comment that the collection rate went from 60% to 71%, is that accurate. Dean stated the rate is 71% collection rate so far this year. Once they started used the billing company, the rate has gotten progressively better.

Hawkey made a motion to adjourn. Cazier seconded. Motion carried. Meeting adjourned at 7:45 p.m.

## Law of the Month

### December 2016 – Motorists need to follow common-sense precautions to meet the challenges of winter driving in Wisconsin

No matter how many Wisconsin winters you've experienced, the inescapable onslaught of ice, snow, and limited visibility will make driving extremely challenging and at times impossible.

When roads are slick with ice or snow, drivers needlessly crash or skid off the road because they were driving too fast for conditions. "The posted speed limits, which are set for dry pavement, may be too fast for conditions when roads are snow covered and slippery. The slogan 'Snow Means Slow' also applies to four-wheel drive and other heavy-duty vehicles. They usually need just as much distance to stop as other vehicles.

A citation for driving too fast for conditions costs **\$213.10** with four demerit points assessed on the driver's record, and a second violation within a year costs **\$263.50** with four points.

Winter weather also can limit visibility, so drivers must remove all frost, ice and snow from their vehicle's windows. To see safely in all directions, you need to clear more than just a small patch on a windshield or rear window. Clearing snow and ice from the lights, hood and roof also helps improve visibility and safety.

State Law requires a vehicle's windshield, side wings, and side and rear windows must be kept clear at all times. Violating this law costs **\$175.30** with two demerit points, and a second violation within a year costs **\$213.10** with two points.

To minimize the dangers of winter driving, here are a few common-sense safety tips:

- Always wear your safety belt. You and your passengers absolutely need this protection even in low-speed "fender-bender" crashes that frequently occur on slick roads.

- Don't use your cruise control in wintry conditions. Even on roads that appear clear, there may be slippery spots, which can cause a loss of traction and a spinout if the vehicle is in the cruise-control mode.
- Watch for slippery bridge decks. They ice up faster than adjacent pavement.
- Look farther up the road than you normally do. If vehicles ahead of you are swerving or show other signs of loss of traction, you should slow down and take extra precautions.
- Brake early. It takes much longer to stop in adverse conditions.
- Don't pump anti-lock brakes. With anti-lock brakes, the correct braking method is to "stomp and steer."
- Don't be overconfident about the traction and stopping distance of four-wheel drive vehicles, which generally won't grip an icy road any better than two-wheel drive vehicles.
- Avoid cutting in front of large trucks, which take longer than automobiles to slow down or stop.
- Leave plenty of room for snowplows. By law, you must stay back at least 200 feet from the rear of a snowplow.
- Obey the Move Over Law, which requires drivers to shift lanes or slow down in order to provide a safety zone for a law enforcement vehicle, tow truck, ambulance, fire truck, highway maintenance vehicle, or utility vehicle that is stopped on the side of a road with its warning lights flashing.
- If your vehicle slides off the road, gets stuck, or becomes disabled, stay inside it if at all possible with your seat belt fastened until a tow truck or other help arrives. If you're inside your vehicle and buckled up, you have protection against out-of-control vehicles. There's no protection outside your vehicle.

## Snow Removal from Sidewalks

All sidewalks must be cleared of snow within 24 hours of snowfall ending. Snow **may not** be put into the street.

### **Snow Blowing or Shoveling Snow back into the road is not legal - Per Wisconsin State**

**Statute 346.94 (5)** PLACING INJURIOUS SUBSTANCE ON HIGHWAY. No person shall place or cause to be placed upon a highway any foreign substance which is or may be injurious to any vehicle or part thereof.

*We ask that you be considerate and not place snow back into the road when cleaning your sidewalks/driveways. This causes a financial burden and can cause accidents with injuries.*

*Thank you for your help.*

The owner or user of each mailbox shall, within twenty-four (24) hours after the end of each snowfall, remove all snow and ice which has fallen or accumulated in front of said mailbox, and shall remove the snow and ice away from the curb or area in front of the mailbox a minimum of fifteen (15) feet on each side of said mailbox.

*Please clear snow from around fire hydrants and water meter readers also.*

## **Bitter Cold Moves into Wisconsin** **Dangerous wind chills expected**

(MADISON) – Dangerously cold temperatures and frigid wind chills are in the forecast for much of Wisconsin this week. Single digit highs around zero with overnight lows well below zero, especially Wednesday into Thursday, are expected. Dangerous wind chills from 10 to 30 below zero are expected overnight.

ReadyWisconsin and the Wisconsin Department of Health Services (DHS) are teaming up to warn people about the bitter weather and precautions you and your family should take to keep safe.

Last winter, 33 cold-related fatalities occurred in Wisconsin between December 1, 2015 and February 29, 2016. Take precautions to keep you and your family safe during the winter cold by staying in heated areas, protecting against carbon monoxide poisoning, monitoring alcohol consumption, and watching for signs of frostbite/hypothermia.

Staying in heated areas is the easiest way to protect your health during periods of extreme cold. Consider visiting public buildings like malls, libraries and community centers if your home is insufficiently heated. Call 211 for information about resources specific to your local area.

While at home, monitor your sources of heat. Any heating system that burns fuel, including your gas furnace and hot water heater, will produce carbon monoxide. **Carbon monoxide** causes headaches, fatigue, dizziness, shortness of breath, chest pain, vomiting, confusion, and ultimately death. If you or someone you know experience any of these symptoms, call 911 and get out of the house to a neighbor's home or local business. Make sure you have working carbon monoxide detectors in your home. Never run a gasoline or propane heater or a grill (gas or charcoal) inside your home or an unventilated garage.

Many of last year's cold-related fatalities were related to **alcohol consumption**. Be especially cautious consuming alcoholic drinks this holiday season while out in extreme cold. Alcohol may seem to keep you warm, but can hasten health effects from the cold if you are outside for an extended period.

**Frostbite** can occur on exposed skin in less than 30 minutes. Symptoms include a loss of

feeling and a white or pale appearance in fingers, toes, ear tips and tip of the nose. If you see these signs, seek medical care immediately!

**Hypothermia** (abnormally low body temperature) symptoms include shivering, exhaustion, confusion, fumbling hands, memory loss, slurred speech and drowsiness in adults and children. In infants, symptoms can include bright red or cold skin and very low energy. If you notice anyone exhibiting any of the symptoms of hypothermia, seek medical care immediately!

**If you must work outside** wear proper clothing for cold and windy conditions. Wear layers and make sure to cover your head, ears and hands. Insulated and water proof boots will also help.

**Overexertion** is dangerous. Cold weather puts an added stress on the heart. Unaccustomed exercise such as shoveling snow or pushing a car can bring on a heart attack or make an existing medical condition such as diabetes, hypertension, or cardiovascular disease worse.

**Pets** also need extra care when the temperatures fall. They should be brought inside when the temperature reaches 30°F with wind chill. Dogs and cats can get frost-bitten ears, nose and feet if left outside during bitter cold weather. Chemicals used to melt snow and ice can also irritate pets' paws – be sure to keep anti-freeze, salt and other poisons away from pets.

## Winter Driving Tips:

- Avoid driving while you're fatigued. Getting the proper amount of rest before taking on winter weather tasks reduces driving risks.
- Never run a vehicle in an enclosed area, such as a garage.
- Make certain your tires are properly inflated.
- Keep your gas tank at least half full.
- If possible, avoid using your parking brake in cold, rainy and snowy weather.
- Do not use cruise control when driving on any slippery surface (wet, ice, sand).
- Always look and steer where you want to go.
- Use your seat belt every time you get into your vehicle.

### Tips for long-distance winter trips:

- Watch weather reports prior to a long-distance drive or before driving in isolated areas. Delay trips when especially bad weather is expected. If you must leave, let others know your route, destination and estimated time of arrival.
- Always make sure your vehicle is in peak operating condition by having it inspected by a AAA Approved Auto Repair facility.
- Keep at least half a tank of gasoline in your vehicle at all times.
- Pack a cellular telephone with your local AAA's telephone number, plus blankets, gloves, hats, food, water and any needed medication in your vehicle.
- If you become snow-bound, stay with your vehicle. It provides temporary shelter and makes it easier for rescuers to locate you. Don't try to walk in a severe storm. It's easy to lose sight of your vehicle in blowing snow and become lost.
- Don't over exert yourself if you try to push or dig your vehicle out of the snow.
- Tie a brightly colored cloth to the antenna or place a cloth at the top of a rolled up window to signal distress. At night, keep the dome light on if possible. It only uses a small amount of electricity and will make it easier for rescuers to find you.
- Make sure the exhaust pipe isn't clogged with snow, ice or mud. A blocked exhaust could cause deadly carbon monoxide gas to leak into the passenger compartment with the engine running.

- Use whatever is available to insulate your body from the cold. This could include floor mats, newspapers or paper maps.
- If possible run the engine and heater just long enough to remove the chill and to conserve gasoline.

### Tips for driving in the snow:

- Accelerate and decelerate slowly. Applying the gas slowly to accelerate is the best method for regaining traction and avoiding skids. Don't try to get moving in a hurry. And take time to slow down for a stoplight. Remember: It takes longer to slow down on icy roads.
- Drive slowly. Everything takes longer on snow-covered roads. Accelerating, stopping, turning – nothing happens as quickly as on dry pavement. Give yourself time to maneuver by driving slowly.
- The normal dry pavement following distance of three to four seconds should be increased to eight to ten seconds. This increased margin of safety will provide the longer distance needed if you have to stop.
- Know your brakes. If you have anti-lock brakes (ABS) and need to slow down quickly, press hard on the pedal—it's normal for the pedal to vibrate a bit when the ABS is activated.
- Don't stop if you can avoid it. There's a big difference in the amount of inertia it takes to start moving from a full stop versus how much it takes to get moving while still rolling. If you can slow down enough to keep rolling until a traffic light changes, do it.
- Don't power up hills. Applying extra gas on snow-covered roads just starts your wheels spinning. Try to get a little inertia going before you reach the hill and let that inertia carry you to the top. As you reach the crest of the hill, reduce your speed and proceed down hill as slowly as possible.
- Don't stop going up a hill. There's nothing worse than trying to get moving up a hill on an icy road. Get some inertia going on a flat roadway before you take on the hill.
- Stay home. If you really don't have to go out, don't. Even if you can drive well in the snow, not everyone else can. Don't tempt fate: If you don't have somewhere you have to be, watch the snow from indoors.

Dec. 2016 News from Your Senior Center

Happy Holidays from the staff at the Oregon Area Senior Center!

This tends to be a busy time of year for everyone, senior and non-senior alike. Unfortunately, Mother Nature can throw us some real curveballs in the middle of all our comings and goings. Snow, ice and bitterly cold temperatures, along with howling winds, can make for dangerous conditions for anyone, regardless of age.

Wisconsin has the unfortunate distinction of being one of the states with the most seniors falling (and dying because of those falls). December sees more Wisconsin seniors falling than any other winter month.

Why is December so treacherous? Perhaps because we are relearning how to cope with what winter throws at us. Perhaps because we are so busy with all the bustle of the holidays, and don't feel that we can just stay home on bad weather days. Indoor falls go up in December too, perhaps because of being in unfamiliar places for social events, perhaps due to over-extending ourselves to decorate, or perhaps due to something as simple as wearing different shoes than we are used to wearing.

Being aware of an increased risk of falls means you can be proactive and lower your risk. Wear shoes or boots with non-slip soles while outdoors. If you use a cane, make sure the rubber tip on the end is not worn smooth. If it is, replace it. Be cautious when walking outdoors, and use a penguin-walk type of shuffle when walking on questionable surfaces. Do not venture onto surfaces that are obviously slick.

Indoors, eliminate throw rugs. Be very aware of your surroundings in unfamiliar places, as it is easy to overlook a step or two and fall. Don't let vanity convince you to wear shoes you aren't used to. Stay off ladders.

If you are interested in having your home assessed for fall risks, let the staff at the Senior Center know, as United Way oversees a program that will assess your home at no cost. You can reduce your risk of falls and avoid being part of an unfortunate statistic.



## Winter Parking Enforcement in Effect

### Parking regulations:
